General Fund-State revenue is transferred to the Drought Preparedness and Response Account then appropriated in sec. 3010 of the 2022 supplemental conference capital budget.

<sup>3</sup> Additional state appropriation authority from the Water Pollution Control Revolving Account so that Ecology can reinvest early loan repayments received in fiscal year 2022 in ready-to-proceed projects, and continue essential work through the Clean Water State Revolving Fund (SRF) Loan Program.

<sup>&</sup>lt;sup>7</sup> Section 7002(7) of the proposed 2022 supplemental conference capital budget directs Ecology to enter into a financing contract for up to \$3,797,000, plus financing expenses and required reserves, pursuant to Chapter 39.94 RCW, for the Lacey headquarters parking garage preservation project. Appropriation authority to support the Certificate of Participation (COP) payments will be requested as part of Ecology's 2023-25 operating budget request.
