Update Chapter 173-460 WAC, Controls for New Sources of Toxic Air Pollutants



Notice to Interested Parties

Ecology is starting the rulemaking process to update Chapter 173-460 WAC, Controls for New Sources of Toxic Air Pollutants. This rule:

- provides specific criteria and conditions for permitting new or modified sources of toxic air pollutants
- builds on the standard permitting framework for new sources (WAC 173-400-110)
- establishes emission thresholds for about 400 toxic air pollutants

Why is this rulemaking needed?

This rule has been in effect since 1991, with the last rule revision in 2009. We think it is time to update the rule and how it is implemented.

Rulemaking Timeline

1. The first rulemaking - July 2018
