The Shoreline Management Act and the Shoreline Master Program (SJC 18.50) apply to all shorelines 200 feet landward of the ordinary high water mark (OHWM) and everything seaward of that line.

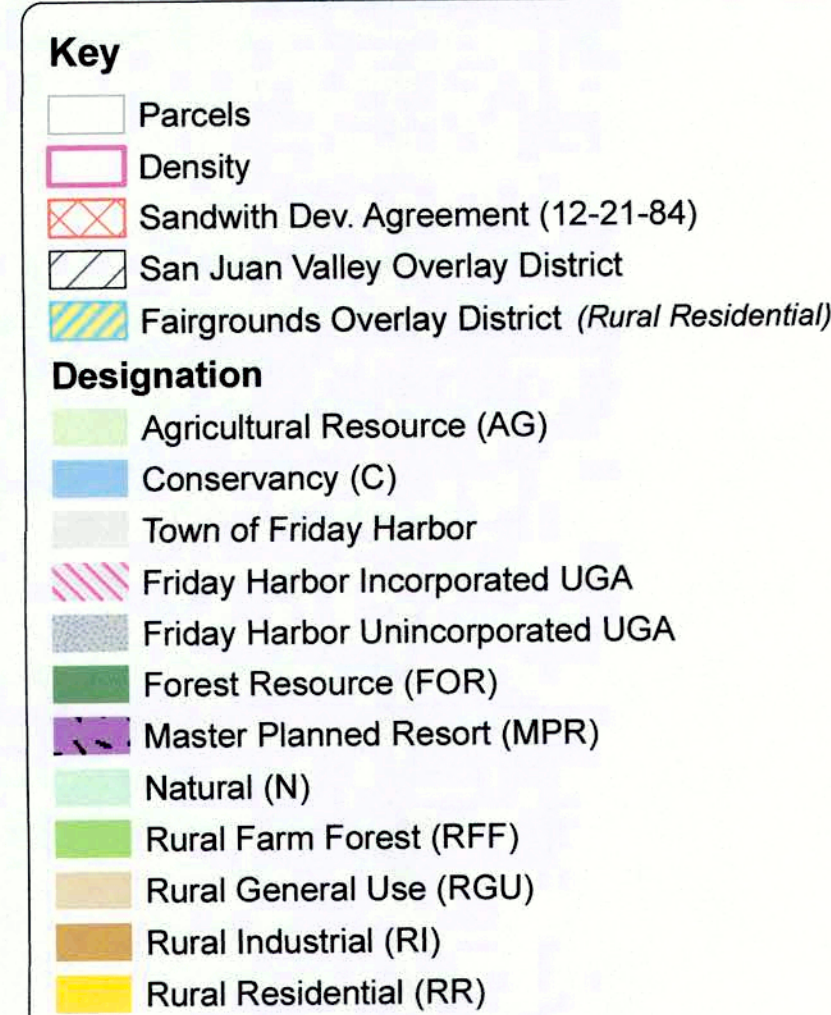
Where a dual designation is shown, the first designation applies landward of the OHWM, the second from the OHWM to the line of extreme low tide (ELT), and the Aquatic environment applies seaward of the ELT line.

All small islands, rocks, and reefs whose designations are not shown on this map are designated Conservancy if in private ownership, or Natural if they are public ownership.

Lake shoreline designations apply 200 feet landward from the ordinary high water mark, and Aquatic applies below that line.

Shoreline densities are controlled by upland densities. There are no separate shoreline densities.

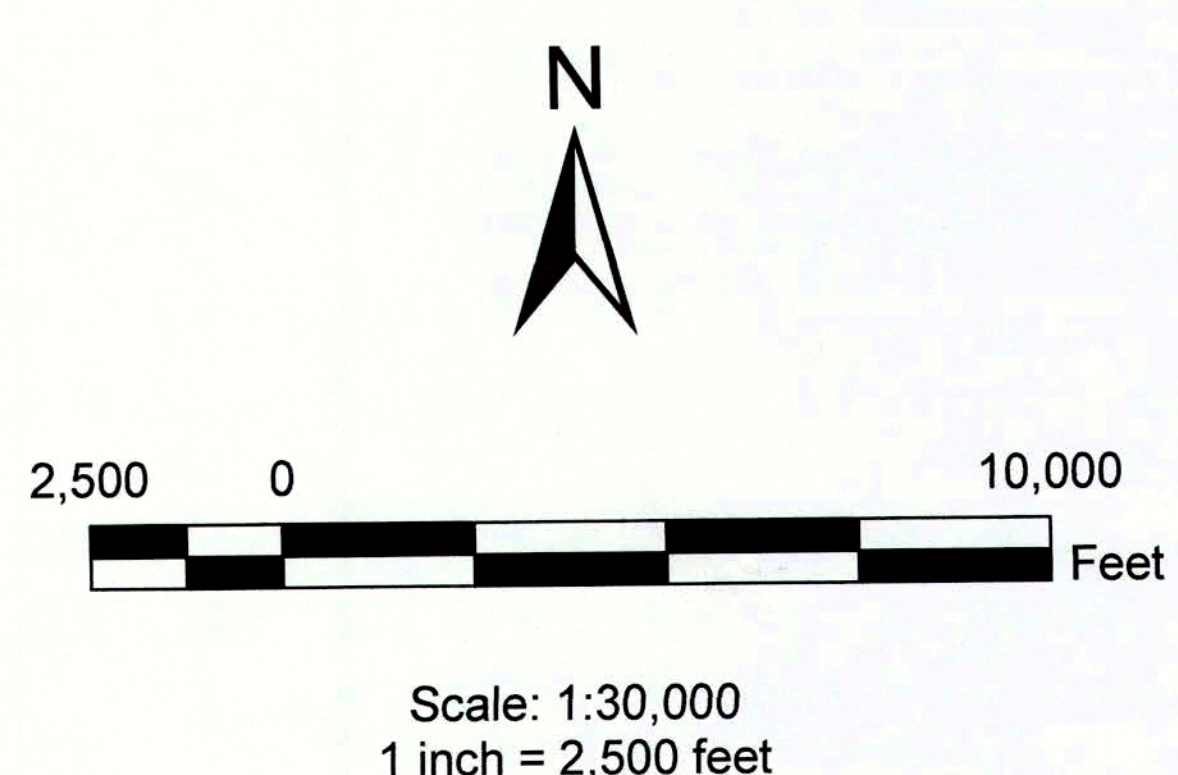
