Dear Michelle,

In accordance with Skamania County Ordinance No. 2017-02, passed by the Board of County Commissioners on 27 June 2017, we are pleased to provide the comprehensive SMP update submittal package to the Department of Ecology for state review, per WAC 173-26-110.

The attached locally-approved SMP document (Item 4) has been revised since the last version you reviewed to account for: (1) the Board's comments in their public hearing on 27 June, (2) additions of definitions for "height" and "average grade" in Chapter 7 per comments provided on 21 June 2017 by WKO Inc., (Mike Greenberg), (3) renumbering section 3.4.9 per your 29 June 2017 e-mail, (4) revisions based on Lower Columbia Fish Recovery Board's comments of 31 May 2017, (5) revisions based on your 17 February 2017 review of the SMP submittal checklist and, (6) revisions based on your 14 June 2017 third review of the document. With regard to items 3 and 5, these changes occurred after the Board's local approval of the SMP, but are consistent with Board's direction to incorporate Ecology's minor changes and edits as described to them at their 27 June 2017 hearing.
