(3) Amended environment designation map(s), showing both existing and proposed designations, together with corresponding boundaries described in text for each change of environment. All proposals for changes in environment designation and re-designation shall provide written justification for such based on existing development patterns, the biophysical capabilities and limitations of the shoreline being considered, and the goals and aspirations of the local citizenry as reflected in the locally adopted comprehensive land use plan;	The environment designation maps of the SMP are not being amended.
(4) A summary of proposed amendments together with explanatory text indicating the scope and intent of the proposal, staff reports, records of the hearing, and/or other materials which document the necessity for the proposed changes to the master program;	 The only text of the SMP proposed for amendment is the reference date of the adopted CAO, shown in Section 3 of Ordinance 2017-077 (a strikeout/ underline version is shown in the application cover letter).
