# STATE ENVIRONMENTAL POLICY ACT DETERMINATION OF NONSIGNIFICANCE (DNS)

<u>Description of Proposal</u>: Fire Mountain Farms (FMF), Inc., a beneficial use facility (BUF) submitted an application to the Department of Ecology to amend its existing coverage under the Statewide General Permit for Biosolids Management. Fire Mountain Farms is proposing to add three fields of approximately 265 acres in the vicinity of Bald Hill Rd and 128<sup>th</sup> Ave SE in Yelm, WA.

Only biosolids meeting the Class B standards will be applied at this site. Biosolids will be applied at agronomic rates for beneficial reuse of nutrients and as a soil conditioner. The new sites meet the criteria set forth for specific site selection in FMF's General Land Application Plan (GLAP). Land application will occur as stated in the Site Specific Land Application Plan (SSLAP) and the biosolids will meet all requirements set forth in WAC 173-308, Biosolids Management.
