

Washington Mandatory Greenhouse Gas Reporting Program

Reported Emissions for 2012 – 2016

Certain large facilities and transportation fuel suppliers are required to report their greenhouse gas (GHG) emissions to Ecology beginning with the 2012 emissions year. Owners or operators of the following are required to report:

- Facilities that emit at least 10,000 metric tons of carbon dioxide equivalent (CO₂e) of greenhouse gases per year in Washington.
- Suppliers of liquid motor vehicle fuel, special fuel, or aircraft fuel that supply products equivalent to at least 10,000 metric tons of carbon dioxide per year in Washington.

The tables below contain data reported to Ecology as of March 1, 2018. The reported emissions are preliminary and have not been fully verified by Ecology. This information is subject to change. Emissions from one table should not be combined with emissions from other tables as there are different accounting methods and overlap of emissions between the tables.

- Table 1 includes information about each facility's onsite emissions.
- Table 2 includes emissions associated with the complete combustion or oxidation of products from petroleum product producers and natural gas distributors.
- Table 3 includes emissions associated with the complete combustion or oxidation of fuels supplied by transportation fuel suppliers under the Washington Department of Licensing Fuel Tax Program.

This dataset does not include all of Washington's emissions. See the Washington State Greenhouse Gas Emissions Inventory (<https://ecology.wa.gov/Research-Data/Scientific-reports/Statewide-greenhouse-gas-inventory>) for statewide emissions totals.
