**Draft rule language: Chapter 173-400 WAC**

**WAC 173-400-025 Adoption of federal rules.** Federal rules mentioned in this rule are adopted as they exist on ~~January 24, 2018~~X[rule proposal publication date]. Adopted or adopted by reference means the federal rule applies as if it was copied into this rule.

**WAC 173-400-030 Definitions**

(102) "**Volatile organic compound (VOC)**" means any carbon compound that participates in atmospheric photochemical reactions.

(a) Exceptions. ...; cis-1,1,1,4,4,4-hexafluorobut-2-ene (HFO-1336mzz-Z); and perfluorocarbon compounds that fall into these classes:

(5) Analysis by federal land manager.

(b) Any notice of construction application for a new or modified source, ... threshold rate (defined in WAC 173-400-030) or any increase in emissions of a toxic air pollutant that causes a modeled concentration increase above the acceptable source impact level for that toxic air pollutant as regulated under chapter 173-460 WAC; or
