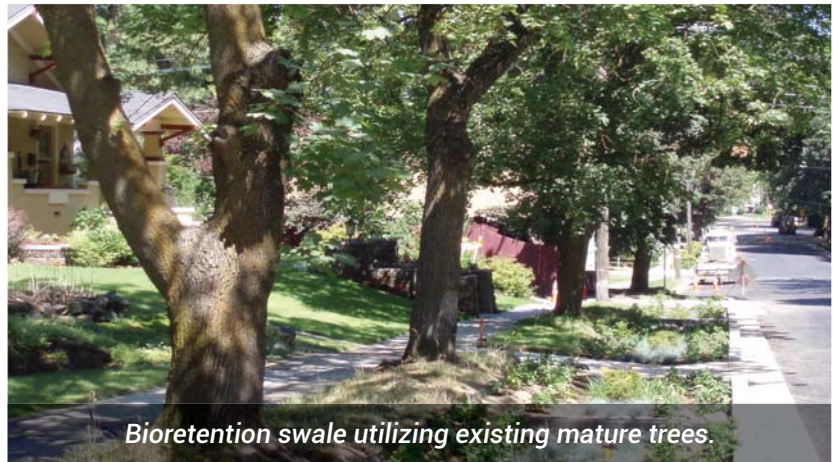

Major Revisions in the Draft 2018 Manual

- New flowcharts to clarify new development and redevelopment requirements in Chapter 2
- Updated BMP template for Chapters 5 and 6
- Updated Site Suitability Criteria
- Clarified and updated the Underground Injection Control (UIC) guidance
- New flow control and runoff treatment BMPs (LID)
- New source control and construction BMPs in Chapters 7 and 8 (SWMMWW)
- Updated dispersion BMP design guidance (HRM)
- Updated Infiltration Rate Determination Guidelines (LID)
- New Site Planning Principles and Design Strategies appendix (LID)
- Updated planting recommendations (LID)

(SWMMWW) = Content integrated from the draft 2019 Stormwater Management Manual for Western Washington

(LID) = Content integrated from the Eastern Washington Low Impact Development (LID) Guidance Manual

(HRM) = Content integrated from the WSDOT Highway Runoff Manual
