Financial Assistance Workshops for State Fiscal Year 2022 Water Quality Combined Funding Program

The Washington State Department of Ecology is holding its annual applicant training workshops. The workshops will include information about the [Water Quality Combined Funding Program](#)¹ (WQC) and the State Fiscal Year 2022 (SFY22) application process. In prior years Ecology held workshops in each of its four regions, but this year the workshops will be held online due to COVID-19 protection orders. There is no cost to attend the workshops. Workshop agendas and registration links and instructions are below.

Funding Sources

The WQC provides grants and low-interest loans for water quality projects across the state through the following funding sources:

- Centennial Clean Water Program (Centennial) grants.
- Clean Water Act Section 319 Nonpoint Source Program (Section 319) grants.
- Clean Water Act State Revolving Fund Program (CWSRF) loans.
- Stormwater Financial Assistance Program (SFAP) grants.

CWSRF and Section 319 include federal funds. See the [SFY22 Funding Guidelines](#)² for specific information on federal funding subrecipient eligibility requirements, activities to be performed, award amounts, program duration, and applicable laws and regulations.

Eligible Applicants

Eligible applicants for WQC include:

- Conservation districts.
- Counties, cities/towns.
- Federally recognized tribes.
- Institutions of higher education if the project is not included in the institution's statutory responsibilities.
- Irrigation districts.
- Local health jurisdictions.
- Not-for-profit organizations that are recognized as tax-exempt by the Internal Revenue Service. Not-for-profit organizations are only eligible for Section 319 funding.
- Port districts.
- Quasi-municipal corporations.
- Sewer districts.

Eligible Projects

WQC provides grants and loans for projects that improve and/or protect Washington's water quality under the following major categories:

- Nonpoint source pollution control activities.
- Onsite sewage system repair and replacement programs.
- Stormwater activities.
- Stormwater facilities.
- Wastewater facilities.

Funding Cycle Schedule

The SFY22 funding application opens at 8:00am on August 11, 2020. All applications must be submitted before 5:00pm on October 13, 2020. See the [WQC Funding Cycles webpage](#)³ for additional information.
