The Washington State Department of Ecology (Ecology) finds the Perry Pallet Mulch and Wattle produced at your facility is functionally equivalent to BMP C121 Mulching and BMP C235 Wattles as described in the 2018 Stormwater Management Manual for Western Washington (SWMMWW) and the 2018 Stormwater Management Manual for Eastern Washington (SWMMEW).

Ecology does not endorse this product or its manufacturer.

Contractors may use the Perry Pallet Mulch and Wattles at construction sites without seeking additional Ecology approval. Installers must follow manufacturer installation and maintenance recommendations.
