On March 1, 2019, Charter Communications, the business name associated with the Diesel Generator at the 1145 Abadie Street property, informed Ecology that the Generator is below the 500 BHP threshold for permitting. At that time, the facility was in compliance with its Air Quality Coverage Order No. 10AQ-E359.

DETERMINATIONS

In relation to the above activities at 1145 Abadie Street, Walla Walla, WA 99362, the Department of Ecology, State of Washington, pursuant to RCW 70.94.152, WAC 173-400-110, WAC 173-460 makes the following determinations:

1. The facility may not operate Diesel Generator(s), with an aggregate of greater than 500 BHP, in the Eastern Region of Ecology jurisdiction without first obtaining a new approval order in accordance with RCW 70-94-152, WAC 173-400-11 and WAC 173-460.
2. Rescission of the Approval Order No. 10AQ-E359 will provide regulatory relief to the permit holder: Charter Communications.

THEREFORE, IT IS ORDERED that Approval Order No. 10AQ-E359 is hereby rescinded. The authorization, terms, and conditions of Order No. 10AQ-E359 are no longer effective.

YOUR RIGHT TO APPEAL

You have a right to appeal this Approval Order to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this Approval Order. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do the following within 30 days of the date of receipt of this Approval Order:

- File your appeal and a copy of this Approval Order with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this Approval Order on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC
