

Floodplains by Design 2027-29 Pre-Application

How to apply:

Applicants interested in applying for a Floodplains by Design (FbD) 2027-29 grant must first submit a pre-application using the format below. Ecology staff will review pre-applications to ensure eligibility based on the grant program's intent. Applicants are strongly encouraged to review the *FbD 2027-29 Funding Guidelines* found on the <u>FbD grants website</u>¹ prior to submitting this pre-application.

What happens next:

After review, Ecology staff will determine if the pre-applications proposed project package meets the eligibility requirement of having flood risk reduction and ecosystem/salmon recovery advancement as main objectives of the proposal. Ecology staff will reach out to pre-applicants with any eligibility concerns and/or recommendations on whether a proposal should move ahead to full application based on meeting these eligibility requirements.

Ecology will invite applicants who meet eligibility requirements to give a virtual presentation to evaluators the week of March 30, 2026. More information about the presentation, including the format, dates, and times will be included in the emailed invitation. After presentations, preapplicants will be invited to submit full applications in Ecology's Administration of Grants and Loans (EAGL) online system. Important deadline:

The deadline to submit the pre-application via email is **5 p.m. on Friday, January 23, 2026.** Save the file as Word or PDF and email Lisa Nelson, Floodplains Restoration Planner, at lisa.nelson@ecy.wa.gov with the subject line "FbD 2027-29 Pre-Application, (Applicant Organization/Project Title)."

Tribal notification requirement:

The pre-application structure meets the Climate Commitment Act requirements for tribal notification. Prior to submitting this pre-application to Ecology, please submit the pre-application to all affected federally recognized Tribes with interest in the project area with an open invitation for further discussion about the project. Ecology created a tribal notification letter template, which is saved to the FbD grants website, for your use if desired.
