Third reading of Bill No. 17-07 relating to processing applications for variances under the zoning code. Motion by Shaw, Richrod to place bill in final passage. Roll call: all yeas. Carried. This will be Ordinance No. 6610.

Third reading of Bill No. 17-08 adopting revised Shoreline Master Program update as approved by the Washington State Department of Ecology. Motion by Shaw, Richrod to place bill in final passage. Roll call: all yeas. Carried. This will be Ordinance 6611.

Report from Personnel Committee and the Mayor recommending that the City Council approve the Mayor's request for an exception to PP 3.20 for Mike Randich's supervision of Steve Randich as a result of the reorganization of the Public Works Department. Motion to adopt. Jeff Cook, Shortt. Motion by Lawrence, Shave to add sunset clause of 6 months. Original motion carried.

Report from Personnel Committee and the Mayor recommending that the City Council approve the Mayors request to change the salary of the Corporation Counsel and change the name to City Attorney. Motion to adopt. James Cook, Richrod. Carried.
