we have, we're going to have
some key concepts for you here.

First thing I want to cover

00:03:04:07 - 00:03:07:10

today is what is the area
that we are talking about?

we call this y one.

00:03:09:20 - 00:03:11:22

Some people say, where are Ryan?

00:03:11:22 - 00:03:16:20

And, I say, why RA we call it
the Nooksack Wira because it's named

00:03:16:20 - 00:03:20:17

after the dominant river feature,
which is the Nooksack River system.

But it includes the entire area
up to the Canadian border,

00:03:26:05 - 00:03:31:05

and Whatcom County's drainage area down
to the southern border of the South Fork.

00:03:31:14 - 00:03:35:05

For that reason,
it includes a little bit of Skagit County

00:03:35:05 - 00:03:39:14

to the south, and it does not include
all of Whatcom County because,

00:03:39:20 - 00:03:44:10

some of that area does not drain
in to the northern watershed here.

The first thing I want to touch on is,

just the general history of water rights
and responsibilities

00:03:53:18 - 00:03:58:06

in the state of Washington
under state law, really, since 1917,

which was the adoption of the surface
water code,

00:04:01:15 - 00:04:05:13

the most high level principles of water
law in Washington.

First, waters are connected,
and that means that we assume

00:04:09:18 - 00:04:13:19

that water taken out, of the ground
or from a stream

00:04:14:01 - 00:04:18:17

can possibly impact water
on another part of that water system

00:04:19:03 - 00:04:21:21

that we know that water is not connected
from.

00:04:21:21 - 00:04:22:12

Absolutely.

00:04:22:12 - 00:04:25:05

From the Canadian border
down to Skagit County.

00:04:25:05 - 00:04:27:09

We're not saying that, but we are,

00:04:28:08 - 00:04:29:10

looking at

00:04:29:10 - 00:04:32:20

the recent generation
of science and hydrology

00:04:32:20 - 00:04:37:12

that indicates that in general,
we cannot assume that water is isolated

00:04:37:17 - 00:04:41:10

so that one water use
might affect a neighbor's water use.

Because of this, water is a public
resource.

00:04:44:22 - 00:04:50:13

Water is, like air or sunlight, something
that belongs to everybody, to the public.

00:04:50:22 - 00:04:56:06

Even though there are private real estate
rights related to water, the water itself

00:04:56:06 - 00:05:00:21

belongs to the public, and as such, it's

regulated by the state of Washington

00:05:00:21 - 00:05:03:21

Department of Ecology.

00:05:05:02 - 00:05:08:09

Also since 1917,

with the adoption of the Surface

00:05:08:09 - 00:05:12:00

Water Code, has been the law
about where water can be used.

00:05:12:00 - 00:05:15:16

And this is something we talk a lot
about in adjudication and in water.

00:05:15:16 - 00:05:17:04

Right documents.

00:05:17:04 - 00:05:20:19

The first principle of this
is the principle of prior appropriation,

00:05:20:19 - 00:05:24:04

which is the principle of first
in time is first and right.

00:05:24:19 - 00:05:29:05

And prior appropriation
means that older uses on a water

00:05:29:05 - 00:05:32:20

source are more secure than newer
or junior uses.

00:05:33:05 - 00:05:36:02

Newer uses are more often interruptible.

00:05:36:02 - 00:05:36:19

That is,

00:05:36:19 - 00:05:41:22

they are susceptible to interruption
when necessary, when there's not enough

00:05:41:22 - 00:05:46:16

water for everyone on the source
in order to protect senior water users.

00:05:46:23 - 00:05:50:07

It's a first in time, first
and right process so that

00:05:50:10 - 00:05:54:06

when there is not adequate
water available, which is often during

00:05:54:06 - 00:05:59:10

some seasons of the year,
that older uses are more secure and newer.

00:05:59:10 - 00:06:01:18

Uses. Junior uses are interruptible.

00:06:03:22 - 00:06:05:04

The second principle

00:06:05:04 - 00:06:08:13

under the water
code has to do with recorded water rights,

00:06:09:04 - 00:06:11:19

that is, that recorded water rights

00:06:11:19 - 00:06:15:13

are maintained by the Department
of Ecology, not by the county.

00:06:15:13 - 00:06:17:02

In Whatcom or Skagit County,

00:06:17:02 - 00:06:20:18

they do maintain, of course,
their own property, real estate records,

00:06:21:03 - 00:06:25:07

but water, right documents are maintained
by the Department of Ecology.

00:06:25:07 - 00:06:30:12

And we'll be talking today about examples
of the kinds of recorded water rights

00:06:30:18 - 00:06:33:24

that we have in a college's files,
and a little bit about

00:06:34:05 - 00:06:37:05

how to read them and what information
you can get from them.

Some water rights,
go back as early as 1917 or thereabouts.

00:06:43:02 - 00:06:45:09

So there are some very old documents

00:06:45:09 - 00:06:49:01

that have been microfilmed
or scanned into a college's records.

00:06:49:20 - 00:06:52:05

Importantly, these recorded water rights

00:06:52:05 - 00:06:55:21

do not include

permit exempt uses like groundwater,

00:06:56:02 - 00:06:59:17

wells that are exempt from permitting

under the permit exemption.

00:07:00:05 - 00:07:03:15

Now, sometimes there could be,

some overlap and we might be able

00:07:03:15 - 00:07:05:01

to touch on that today.

00:07:05:01 - 00:07:09:00

But as a general rule, water

use that is permit exempt is not

00:07:11:09 - 00:07:12:03

does not have a

00:07:12:03 - 00:07:15:12

recorded right document

in it, associated with it.

00:07:15:12 - 00:07:17:03

And that is because it was exempt.

00:07:17:03 - 00:07:20:19

And the, well, user was never required
to apply for a permit

00:07:21:00 - 00:07:23:14

and will not have a permit or certificate.

00:07:23:14 - 00:07:25:20

The other important
point of record of water

00:07:25:20 - 00:07:30:03

rights is that written quantities
on a water right are not guaranteed,

00:07:30:10 - 00:07:33:06

and there are a few reasons for that.

00:07:33:06 - 00:07:37:16

one reason
is that even if water is on a certificate,

00:07:37:23 - 00:07:42:00

water use after, the late 1960s is subject

00:07:42:00 - 00:07:45:15

to the principle of relinquishment
for ongoing nonuse.

00:07:46:00 - 00:07:49:11

That's a pretty complicated concept
that we might not have time

00:07:49:11 - 00:07:53:08

to cover today, because we really want to
be just orienting people to water, right?

00:07:53:08 - 00:07:54:18

Documents.

00:07:54:18 - 00:07:57:12

The second reason
written quantities are not guaranteed

00:07:57:12 - 00:08:00:12

is that, some water rights forms,

00:08:00:20 - 00:08:03:20

they represent a self-reporting water,

00:08:03:22 - 00:08:08:23

water use that has not been reviewed
or affirmed by the Department of Ecology.

00:08:09:08 - 00:08:12:09

And, Kelly Hamilton will be talking
for a moment about those.

So I'm

00:08:14:04 - 00:08:17:24

going to turn today to Kelly Hamilton,
who is our adjudication

so what are water rights?

00:08:31:23 - 00:08:36:00

here we have the definition of what, water
rights are.

00:08:36:17 - 00:08:39:20

it is a right, to a, sorry, a water.

00:08:39:20 - 00:08:43:05

It is a legal right to use
water for a beneficial use

00:08:43:05 - 00:08:47:23

of a reasonable quantity of public water
for a beneficial purpose

00:08:48:04 - 00:08:52:18

during a certain period of time
occurring at a certain place.

00:08:53:10 - 00:08:57:21

and we'll kind of we'll talk about some of
these key points later in the slides.

next slide. Thanks.

00:09:01:14 - 00:09:03:06

A water rate can be,

00:09:03:06 - 00:09:06:06

for either groundwater or surface water.

00:09:06:13 - 00:09:11:14

Groundwater is water that collects

or flows beneath the Earth's surface,

00:09:11:20 - 00:09:15:13

usually withdrawn

from the ground using a water well.

00:09:16:13 - 00:09:17:19

a surface water is

00:09:17:19 - 00:09:21:06

water that is pooled

or flowing above the Earth's surface,

00:09:21:15 - 00:09:27:01

including water from lakes, rivers,

streams, creeks, and springs.

00:09:27:22 - 00:09:30:22

Next slide please.

00:09:33:00 - 00:09:36:00

There are three main types of water rate

documents.

00:09:36:02 - 00:09:41:13

Water rate claims, including both short

form and long form claims.

00:09:42:00 - 00:09:45:02

Water rate permits and certificates.

00:09:46:01 - 00:09:49:01

Next slide please.

00:09:49:18 - 00:09:52:03

A water rate claim is an old claim

00:09:52:03 - 00:09:57:00

form filed with ecology
between 1967 and 1998,

00:09:57:23 - 00:10:00:00

showing a water use that

00:10:00:00 - 00:10:03:03

predates ecologies permitting system.

00:10:03:17 - 00:10:08:10

These document
a person's assertion of a water use prior

00:10:08:10 - 00:10:11:17

to 1917 for surface water, and prior

00:10:11:17 - 00:10:14:17

to 1945 for groundwater.

00:10:14:24 - 00:10:17:16

These documents are important
for demonstrating

00:10:17:16 - 00:10:20:17

an early use of water that predate

00:10:20:17 - 00:10:23:17

those water codes.

00:10:24:06 - 00:10:26:13

please note that a water rights claim

00:10:26:13 - 00:10:32:01

is different than a court claim form
that will meet need to be submitted,

00:10:32:07 - 00:10:36:22

filled out and submitted to the court
as part of the adjudication process.

00:10:37:03 - 00:10:40:05

They have very similar names,
but they are different things.

00:10:42:00 - 00:10:43:06

Next.

00:10:43:06 - 00:10:46:05

slide, please.

00:10:46:05 - 00:10:50:04

This is an example of a short form
water rights claim.

00:10:50:17 - 00:10:56:01

Short form claims lack many details,
including the source location,

00:10:56:07 - 00:10:59:01

the date of first putting water to use,

00:10:59:01 - 00:11:02:01

and the quantities
claimed under the claim.

00:11:03:03 - 00:11:06:21

short form
claims are for small quantities of water,

00:11:06:21 - 00:11:09:21

including water, for domestic use

00:11:10:01 - 00:11:14:24

in home use, up to 5000 gallons
per day, water for stock watering,

00:11:15:10 - 00:11:19:08

and water

for irrigation of up to a half an acre

00:11:19:15 - 00:11:22:15

of lawn and garden.

00:11:24:07 - 00:11:28:07

It should also be noted

that water rate claims are attached

00:11:28:07 - 00:11:32:16

to the land described on the document,

and therefore do not need

00:11:32:16 - 00:11:35:16

to be transferred over to new land owners.

00:11:36:19 - 00:11:39:19

Next slide please.

00:11:41:21 - 00:11:44:21

so this is an example of a long form

claim.

00:11:44:22 - 00:11:48:23

As you can see,

these have much more detailed information

00:11:48:23 - 00:11:50:19

than the short form claims do.

00:11:51:20 - 00:11:52:17

including

00:11:52:17 - 00:11:55:17

information like the name and address

00:11:55:17 - 00:11:59:02

of the original applicant

or the original claimant.

00:11:59:02 - 00:12:00:24

Excuse me.

00:12:00:24 - 00:12:03:24

because, again,

claims are attached to the land.

00:12:04:06 - 00:12:07:09

The name and address does not need

to be under

00:12:07:09 - 00:12:10:09

the current land owner's name in order,

00:12:11:05 - 00:12:14:05

to be, attached to the land.

00:12:14:13 - 00:12:17:04

it also includes quantities,

00:12:17:04 - 00:12:19:16

including the quantity claimed

00:12:19:16 - 00:12:22:16

and the, quantity currently used.

00:12:23:20 - 00:12:26:20

the source, location and type.

00:12:27:15 - 00:12:29:15

the bottom circle is the place

00:12:29:15 - 00:12:32:16

of use of this claim document.

00:12:32:23 - 00:12:37:01

And at the very bottom,

the bottom area arrow describes

00:12:37:01 - 00:12:39:07

the purpose of use or what?

00:12:39:07 - 00:12:41:07

What, What use?

00:12:41:07 - 00:12:43:24

They're claiming the water for.

00:12:43:24 - 00:12:46:24

next slide please.

00:12:48:12 - 00:12:51:11

So the most important parts of a water
rate document

00:12:51:11 - 00:12:54:15

are what we call the water rate PS and QS.

00:12:55:23 - 00:12:58:23

and not all water
rates will have all of the PS

00:12:58:23 - 00:13:03:07

and QS that every water rate
will have at least a few of these.

00:13:04:23 - 00:13:05:09

under the

00:13:05:09 - 00:13:08:09

PS column, we have the priority date,

00:13:08:09 - 00:13:12:18

which is usually the date
a water rate application was submitted to.

00:13:12:18 - 00:13:14:10

Ecology.

00:13:14:10 - 00:13:17:07

the point of diversion or withdrawal?

00:13:17:07 - 00:13:20:21

describe the location

that is authorized under the water.

00:13:20:21 - 00:13:21:18

Right.

00:13:21:18 - 00:13:26:04

The location of the well or the source

that is authorized under the water.

00:13:26:04 - 00:13:27:03

Right.

00:13:27:03 - 00:13:30:13

the place of use describes

where water can be used.

00:13:30:21 - 00:13:35:04

The purpose of use describes

what water can be used for.

00:13:35:13 - 00:13:39:22

The period of use describes what,
when the water can be used,

00:13:40:12 - 00:13:44:20

and any provisions on a water rate
document.

00:13:44:21 - 00:13:47:21

Certain requirements for using the water

00:13:49:00 - 00:13:49:22

under the QS.

00:13:49:22 - 00:13:53:20

Com we have the key
or instantaneous quantity,

00:13:54:01 - 00:13:56:23

or the rate of withdrawal or diversion.

00:13:56:23 - 00:14:00:15

It's usually described in gallons
per minute for groundwater

00:14:00:21 - 00:14:04:11

and in cubic feet
per second for surface water rights.

00:14:05:21 - 00:14:08:23

the second
quantity that's usually on a water rate

00:14:09:00 - 00:14:14:18

is the annual quantity or how much water
you are allowed to use within a year.

00:14:15:03 - 00:14:18:12

This is always described in acre
feet per year.

00:14:19:08 - 00:14:23:19

which is one acre, one foot deep of water.

00:14:24:11 - 00:14:28:08

is also can be calculated by multiplying

00:14:28:08 - 00:14:32:05

it by 325,851 gallons.

00:14:32:22 - 00:14:37:14

to come up with a gallons
per day or sorry, gallons per year.

00:14:37:20 - 00:14:39:17

Quantity.

00:14:39:17 - 00:14:42:17

next slide.

00:14:44:13 - 00:14:47:18

So a water rate permit gives permission

00:14:47:18 - 00:14:51:18

to use water to pursue a certain project.

00:14:52:20 - 00:14:54:18

a project,

00:14:54:18 - 00:14:55:02

sorry.

00:14:55:02 - 00:14:58:16

A permit will include a development
schedule, including,

00:14:59:07 - 00:15:02:13

dates to begin construction
and complete construction

00:15:02:23 - 00:15:06:02

and to put the water
to full beneficial use.

00:15:07:01 - 00:15:11:01

A water rate permit may lead to a water
rights certificate

00:15:11:08 - 00:15:14:04

if the water use is fully perfected.

00:15:16:22 - 00:15:20:04

a water rate permit is personal property

00:15:20:11 - 00:15:24:12

and does need to be transferred

with the sale of the property.

00:15:24:24 - 00:15:29:05

we have forms, and ecology,

that you can fill out

00:15:29:05 - 00:15:32:23

and submit with the new property

owner to get that permit transferred.

next slide please.

So this is an example of a water rate

00:15:41:03 - 00:15:45:19

permit, and I've, circled

some of the key, P's

00:15:45:19 - 00:15:50:04

and Q's of the water rate,
including the priority date.

the instantaneous quantity and annual

00:15:53:18 - 00:15:56:18

quantity or key and QA.

00:15:57:01 - 00:15:59:12

the purpose and period of use

00:15:59:12 - 00:16:02:12

is indicated with the arrow.

00:16:02:13 - 00:16:05:10

this is the kind of the top
half of the permit.

00:16:05:10 - 00:16:08:10

next slide please.

00:16:08:10 - 00:16:11:01

and here is the bottom
half of that permit.

00:16:11:01 - 00:16:14:16

it describes
the point of diversion or withdrawal.

Then the place of use
and then at the very bottom

00:16:18:06 - 00:16:22:05

is the development schedule
where it gives dates to begin

00:16:22:05 - 00:16:26:15

the project, complete the project
and put the water to full beneficial use.

Once a permit is perfected,
a water rights certificate may be issued.

Like water rate claims.

00:16:37:17 - 00:16:41:10

Water rights certificates
are attached to the land and do not need

00:16:41:10 - 00:16:44:10

to be transferred

with the sale of property.

00:16:44:23 - 00:16:47:23

next slide please.

Again,

I've circled some of the P's and Q's,

00:16:51:10 - 00:16:54:21

including the priority date,

the source type.

00:16:55:00 - 00:16:58:00

This one is for an infiltration trench.

the QA and key.

00:17:00:21 - 00:17:04:19

the purpose

and period of use is also described.

00:17:05:10 - 00:17:08:08

and then this one is for an irrigation

water.

00:17:08:08 - 00:17:14:13

It also, indicates the number of irrigated

acres authorized under the certificate.

And this is the bottom

half of that certificate

00:17:21:12 - 00:17:24:05

that describes, point of withdrawal,

00:17:24:05 - 00:17:27:05

diversion location, the place of use.

And then this one has

an example of a provision,

00:17:31:18 - 00:17:32:10

of the water.

00:17:32:10 - 00:17:33:17

Right.

00:17:33:17 - 00:17:36:21

it's a provision regarding,

it being a family

00:17:36:21 - 00:17:39:21

farm permit.

00:17:40:11 - 00:17:41:13

next slide.

00:17:41:13 - 00:17:44:13

Robin, I believe it's back to you.

timeline of the wire one adjudication.

As many of you might have heard,
the adjudication was filed last week,

00:18:10:00 - 00:18:13:06

May 1st, in Whatcom County Superior Court.

00:18:13:23 - 00:18:18:06

The next step in the adjudication
is for the court to order a summons,

either short form or long form.

claims registry periods

So are there are different ways those
kind of water right claims could, appear?

those are the kind of

have a different legal nature
than permits or certificates,

but for purposes of this form,
to keep it very clear and very simple,

in one single place.

when Kelly was showing us the,

claims registry forms, the ones that say
water rights claim at the top.

They have an indication on there
about when water was first

00:30:31:08 - 00:30:32:20

put to beneficial use.

00:30:32:20 - 00:30:37:14

So that would be another time
that a water user could take information

00:30:37:14 - 00:30:40:20

from an old document and put it on, a new

00:30:41:00 - 00:30:44:00

on the new adjudication court claim form.

00:30:44:04 - 00:30:47:16

If for some reason there are different
document, different dates available,

00:30:48:04 - 00:30:51:05

to a water claimant,
they should put those on here.

00:30:52:02 - 00:30:54:09

even if, they,

00:30:54:09 - 00:30:58:07

if there's a reason that they disagree
with the earlier, dates

00:30:58:07 - 00:31:01:08

on other documents, it would be important
to put those down here.

So the ecology

and eventually the court would be able

00:31:04:20 - 00:31:08:01

to look at all of that information

when reviewing the,

00:31:09:04 - 00:31:10:01

when reviewing the

00:31:10:01 - 00:31:13:01

adjudication, court claims form.

00:31:14:23 - 00:31:17:19

So here are some important questions

that we have.

I know we're open to questions here,

but we have heard many questions,

highest level ones up here

and most important

for us to be talking about today.

And that is how can I protect my right
to use water in that adjudication?

And that answer to that, fundamentally,
is to fill out a claim form,

00:31:49:00 - 00:31:52:00

filing adjudication court claim form.

00:31:52:04 - 00:31:54:22

there are and there is a \$25 cost

00:31:54:22 - 00:31:57:22

or fee associated with the court
claim form,

00:31:58:11 - 00:32:01:15

that is currently in place at Whatcom
County Superior Court.

00:32:02:12 - 00:32:04:17

I also want to let you know
that there is a fee

00:32:04:17 - 00:32:08:01

waiver process,
that the court is developing right now,

00:32:08:17 - 00:32:12:08

that will allow people
who are unable to pay the fee,

00:32:13:02 - 00:32:15:10

to apply to the court for a fee waiver.

00:32:17:10 - 00:32:17:22

the second

00:32:17:22 - 00:32:20:24

point here is what
we've been talking about today, which are,

to, protect your right to use
water in the long term.

00:32:25:22 - 00:32:28:08

When you fill out the court claim form,

00:32:28:08 - 00:32:31:18

refer to previous documents
if you have any.

And that would be a permit certificate
or an old,

00:32:35:08 - 00:32:38:04

claim form.

00:32:38:04 - 00:32:40:13

The second important thing
about protecting

00:32:40:13 - 00:32:44:23

right to use water
ongoing in the adjudication, is to include

00:32:44:23 - 00:32:47:23

the best information

you have about your current water use.

00:32:49:12 - 00:32:53:06

And then the other point here
is looking at historic water use.

00:32:53:06 - 00:32:54:10

And we understand that

00:32:54:10 - 00:32:58:05

this is a difficult thing to understand,
especially if this property hasn't

00:32:58:05 - 00:33:02:03

been under your personal control
or your family's control through history.

But it is important to learn what you can
about historic water use, and

00:33:06:18 - 00:33:11:07

that goes back to the very first slides
we have today about seniority.

If water has been in use on your property
longer than you have used it,

00:33:17:04 - 00:33:20:11

this is the opportunity
to secure a senior priority date

00:33:20:16 - 00:33:24:12

by providing information
about your early historic water use.

00:33:25:07 - 00:33:30:03

So, as the court claim forms opens up
and there is the ability

00:33:30:03 - 00:33:33:03

to submit the adjudication court
claim form.

00:33:33:04 - 00:33:36:03

There will be resources available
about obtaining

00:33:36:03 - 00:33:39:03

historic water use, information.

00:33:39:10 - 00:33:42:12

examples of that are,
of course, the documents

00:33:42:12 - 00:33:44:03

that we've been discussing today.

00:33:44:03 - 00:33:46:20

That's a source of historic information.

00:33:46:20 - 00:33:51:04

There also can be information
through, things like aerial photos.

00:33:51:13 - 00:33:55:02

and there are sources in the community
for historic aerial photos,

00:33:55:08 - 00:33:59:10

going back, in fact, a little earlier
than you might even think, from the first,

00:34:00:08 - 00:34:04:24

commercial or scientific aircraft
flyovers of the area, of the area.

00:34:05:13 - 00:34:06:21

took photographs.

00:34:06:21 - 00:34:11:03

And while it's not, possible to see from
those earliest black and white photos,

00:34:11:08 - 00:34:15:02

perhaps not possible to see exactly,

what might have been growing there.

It does provide information about where
land may have been cultivated or forested,

00:34:20:10 - 00:34:24:05

or other really important information
about the history of your land

00:34:24:12 - 00:34:27:09

that could inform the history
of your property.

00:34:27:09 - 00:34:31:12

Other information about historic water
use could be available from the county.

00:34:31:24 - 00:34:35:14

for instance,
county tax records include when,

00:34:36:17 - 00:34:37:10

buildings were

00:34:37:10 - 00:34:40:11

developed on property,
which could tell when residents

00:34:40:11 - 00:34:43:16

or barns and other outbuildings
were developed on the property.

00:34:43:22 - 00:34:46:22

That would also be information
where you would get,

00:34:47:22 - 00:34:51:09

some facts about your historic water
use to put on your court

00:34:51:09 - 00:34:54:09

claim form.

00:34:55:11 - 00:34:55:20

All right.

00:34:55:20 - 00:34:59:03

So that is the information
we have today about water rate documents.

00:34:59:04 - 00:35:02:06

Now, Sheila, you've
got this really great information here.

we're always looking
to improve our process for outreach.

in the sales agreement,

which rarely happens.

So if you, purchase a property,

and your water rate

does not have your water rate

00:42:01:12 - 00:42:06:03

certificate or claim does not

have your name on it, That's okay.

It was transferred

with the sale of the property.

However, you should be aware

that if it's an application,

a water application,

or a water rate permit,

where the water rate
is a pertinent to that.

A question that came up.

to use that water?

as much research

if they know who owned it previously

before them.

00:44:22:09 - 00:44:24:18

if they're still around,
try to talk to them.

Maybe talk to some neighbors.

you could also,
look at historical aerial photos

00:44:31:19 - 00:44:36:13

to see if you can tell if there's
been, irrigation happening there

or if there's some,
crop located on the property.

you really do want to do your best to,

look at the historic
historical use of the water, right.

a water rate document

necessarily mean there is a water, right.

associated with the property,

in the quantities on the water rate

permit certificate, claim document.

I hope that makes sense.

Kelly.

00:45:26:01 - 00:45:26:21

all right.

00:45:26:21 - 00:45:30:15

There's tons of great questions, so
I'm just I'm going to try and consolidate,

a few into a general question
and then some subparts.

And Robin, and, I think, ehm,
this that you and the high level

question is what if I, am a water user?

Well, for our single domestic use,

who should be putting in paperwork

in the adjudication in that situation?

Thanks, Casey.

so we are developing,

00:46:23:13 - 00:46:26:13

and really improving

the draft instructions

00:46:26:13 - 00:46:30:04

to make it as clear as possible

for these kinds of situations.

We know that often, people share wells,

00:46:34:08 - 00:46:37:13

either in a large formal system

or just between neighbors.

the adjudication court

claim form will have a different place

00:46:41:16 - 00:46:44:16

to put, the point of,

00:46:45:04 - 00:46:49:02

diversion or withdrawal

and the point place of use.

And so for a lot of water users,
it will be a simple matter

00:46:53:04 - 00:46:57:10

of bringing forward their water use and
just putting down that point of diversion,

00:46:57:10 - 00:47:00:17

even if it's on a neighbor's property,
because those could be,

00:47:01:08 - 00:47:03:01

independent of each other.

in other cases, it could be

00:47:06:07 - 00:47:09:22

an organized, use like a group system,

00:47:10:23 - 00:47:14:11

something, like Group B systems,
which are,

up to 14,

00:47:17:22 - 00:47:19:20

connections, I believe,

00:47:19:20 - 00:47:22:11

where it's organized in a more formal way.

And in those kind of situations, users
may want to either get together and submit

a form, together for the entire group use
as if it's a little.

It's a water system with its own,

and let's say we've got a member.

If it's a water,
a larger water association in in addition

to just an exempt well,
what if somebody has a water, right.

Let's say
there is an irrigation water, right?

That covers 40 acres.

And those 40 acres have been subdivided,
and two different owners

now each have 20 acres.

Who should be putting in a form,

00:48:41:04 - 00:48:44:08

a corp claim form

in, in that kind of scenario.

And, Casey, this is a really common
scenario, as Kelly knows,

throughout the area

because we know that property

has a history of going from larger parcels
to smaller ones.

00:48:57:04 - 00:49:00:00

That's

how land has traditionally been developed.

In this case, again,
we're going to try to get the instructions

00:49:03:22 - 00:49:08:08

very clear on the, on the form itself.

00:49:08:08 - 00:49:09:01

So I,

00:49:10:06 - 00:49:10:22

I think I say

00:49:10:22 - 00:49:16:05

today, is to try to help people understand
what to anticipate, but I, doesn't

00:49:16:05 - 00:49:19:14

take precedence over what's end up
being printed on the instructions.

In general, individuals are going to bring

their own claim for their water
use on their own property.

So unless these two neighbors
really operate together

into the future and want to have owned

the same water right forever together in,

the adjudication is the time for them
to establish their independent rights

00:49:47:18 - 00:49:53:00

to each other and the way to do that
is to submit separate court claim forms.

And each user
would submit a court claim form,

00:49:57:12 - 00:50:02:13

and they would both put the same number
of the parent water right on there,

00:50:02:16 - 00:50:07:03

but they would each need to
put their current use, their historic use,

and the original water right
that they originally branched out from.

Now, the,
concern about that might be what it

00:50:15:14 - 00:50:18:15

how does the water divide
between these two?

if it truly was originally 40

and half to 220 parcels,
maybe it is very straightforward.

In that case,

it would probably be helpful for neighbors

00:50:33:24 - 00:50:37:13

to work together to understand

the history of their property.

so that when those come,

into, ecology for review,

ecology has

an understandable history

and set of documents to look at.

this and really that the top level answer

is that the adjudication
is the time to set the documentation

for your future water rights,
and so that is the time for individuals

00:51:20:19 - 00:51:24:20

to submit their own court claim form

for the future of their property.

Thanks, Robin.

and if somebody is a member,
they receive their water

00:51:30:19 - 00:51:35:16

from a municipality like the city of
Linden, the city of Ferndale,

and all
of their water comes from the city.

00:51:40:04 - 00:51:43:17

They don't need to complete a court
claim form.

00:51:43:17 - 00:51:46:10

Is that correct?

00:51:46:10 - 00:51:48:17

Yes. If, an individual

00:51:48:17 - 00:51:52:14

only takes water

from a city or a service system

00:51:52:14 - 00:51:53:22

and does not have their own

00:51:53:22 - 00:51:57:12

well, does not have their own pump

in a streamer River Creek,

00:51:57:21 - 00:52:02:07

they do not need to complete a court claim

form if they are only a customer.

00:52:02:15 - 00:52:06:04

Now, in a lot of cases, there's overlap

between individuals

00:52:06:04 - 00:52:12:03

who are in a service area and either have

wells or they are part of an old water.

00:52:12:03 - 00:52:12:18

Right.

00:52:12:18 - 00:52:16:05

So I know we sent out postcards

a few weeks ago, and a lot of people were

concerned or confused because they were in
a water system and still got a postcard.

Often that is because an old historic
water right covers that place of use,

but they do not need to be, concerned

per day for domestic use

and up to 1/12 of an acre
of noncommercial lawn and garden.

so if you're home and,
well went in prior to 2020,

you are under the old rules.

So up to 5000 gallons
per day for domestic use

noncommercial lawn and garden.

then you are subject
