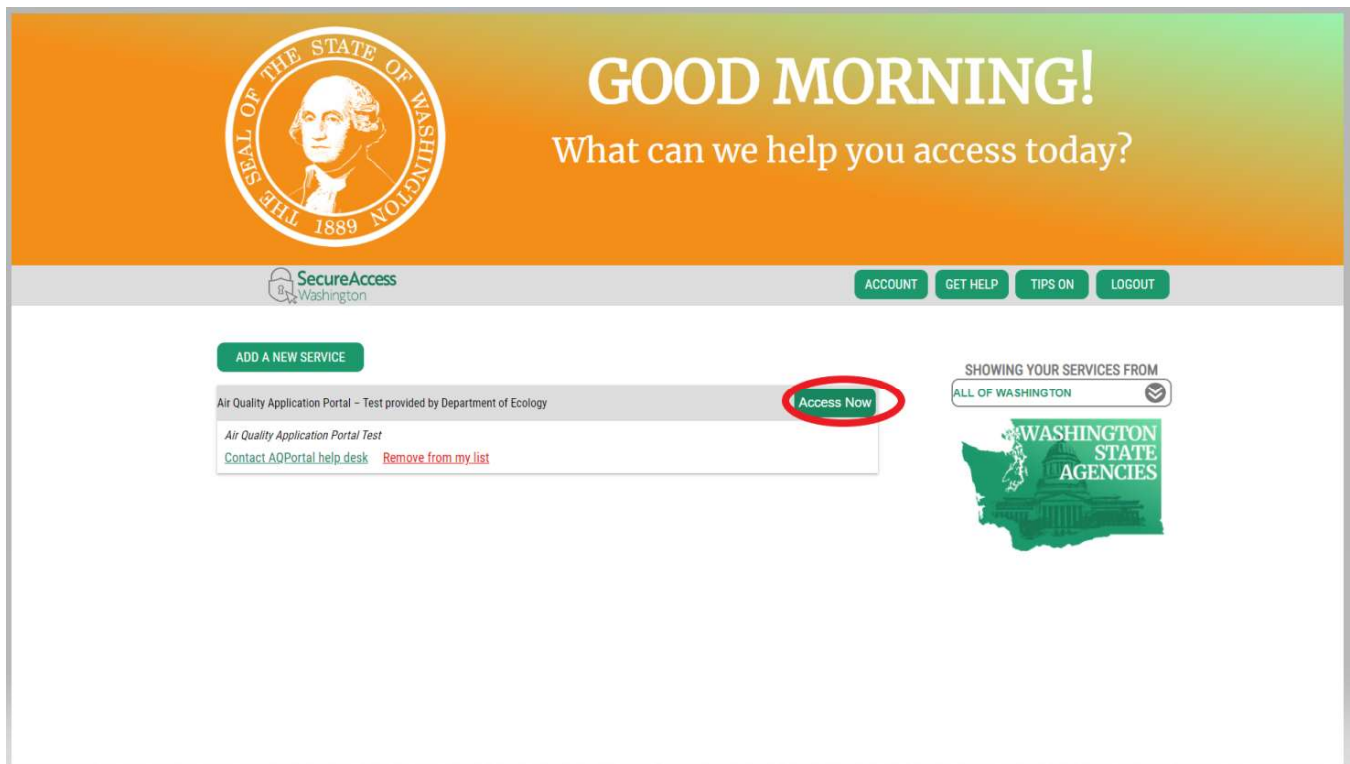
Access Air Quality Source Management System

In order to access the Air Quality Source Management System (SMS) you need to have a Secure Access Washington (SAW) account:

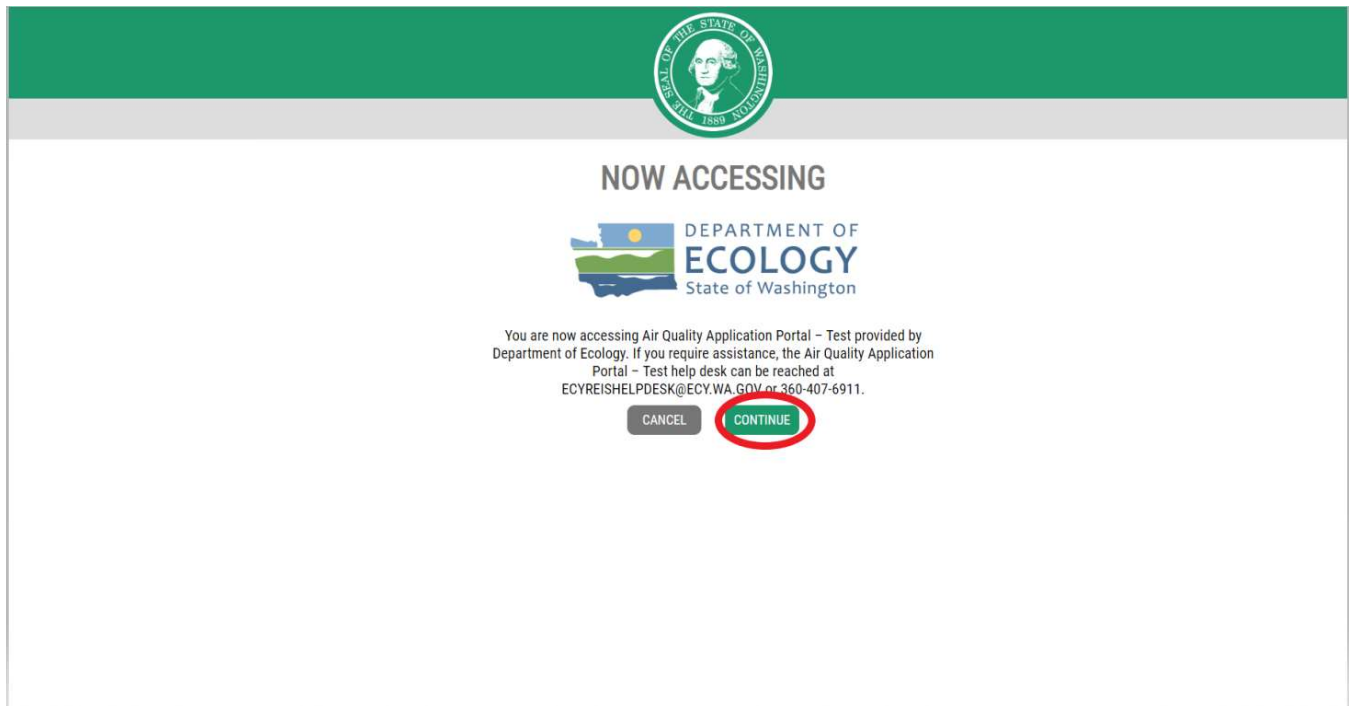
- If you are registering for a new SAW account, please follow the SAW and Air Quality Portal instructions on Ecology's website.

Steps for Accessing SMS

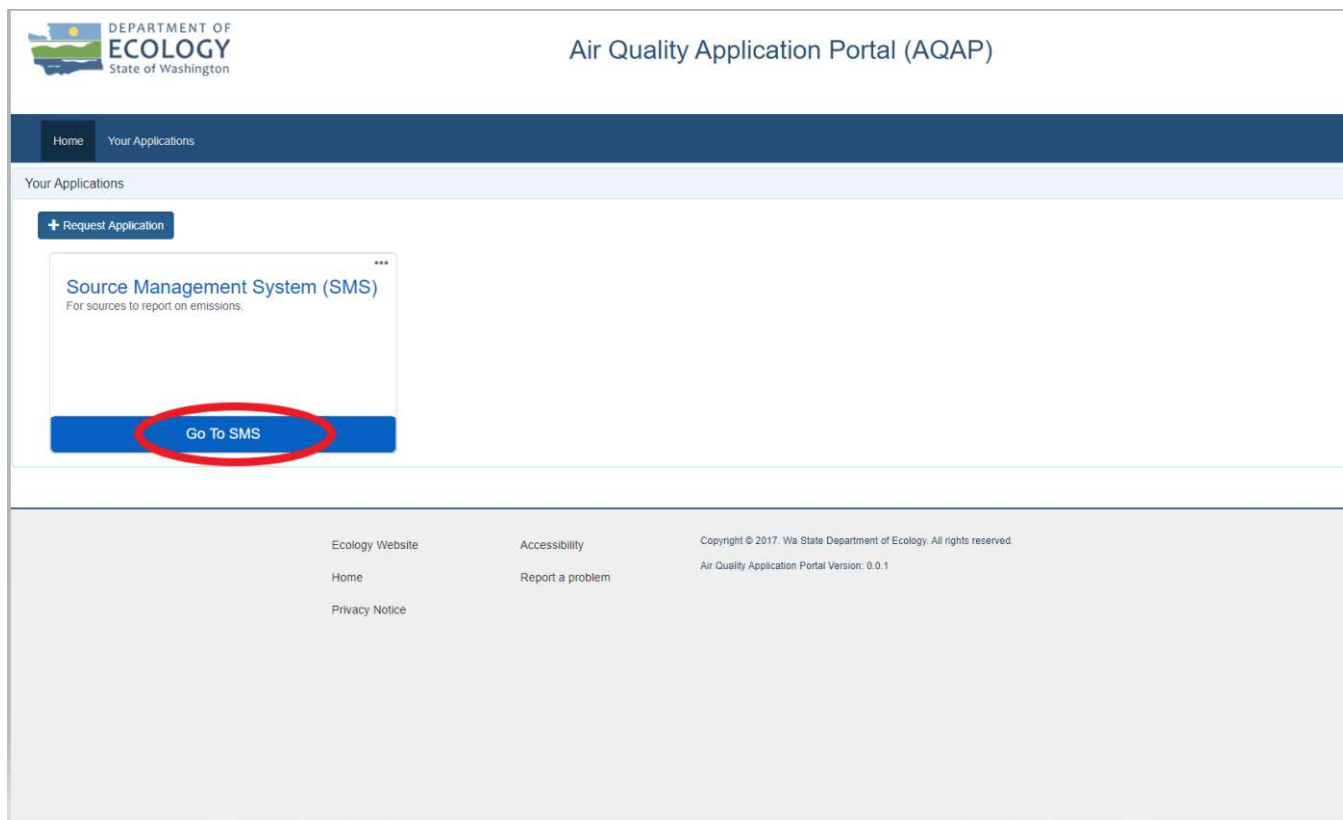
- 1.1. Log into SAW <https://secureaccess.wa.gov> in your internet browser.
- 1.2. Click on "Access Now" button in the Air Quality Application Portal.



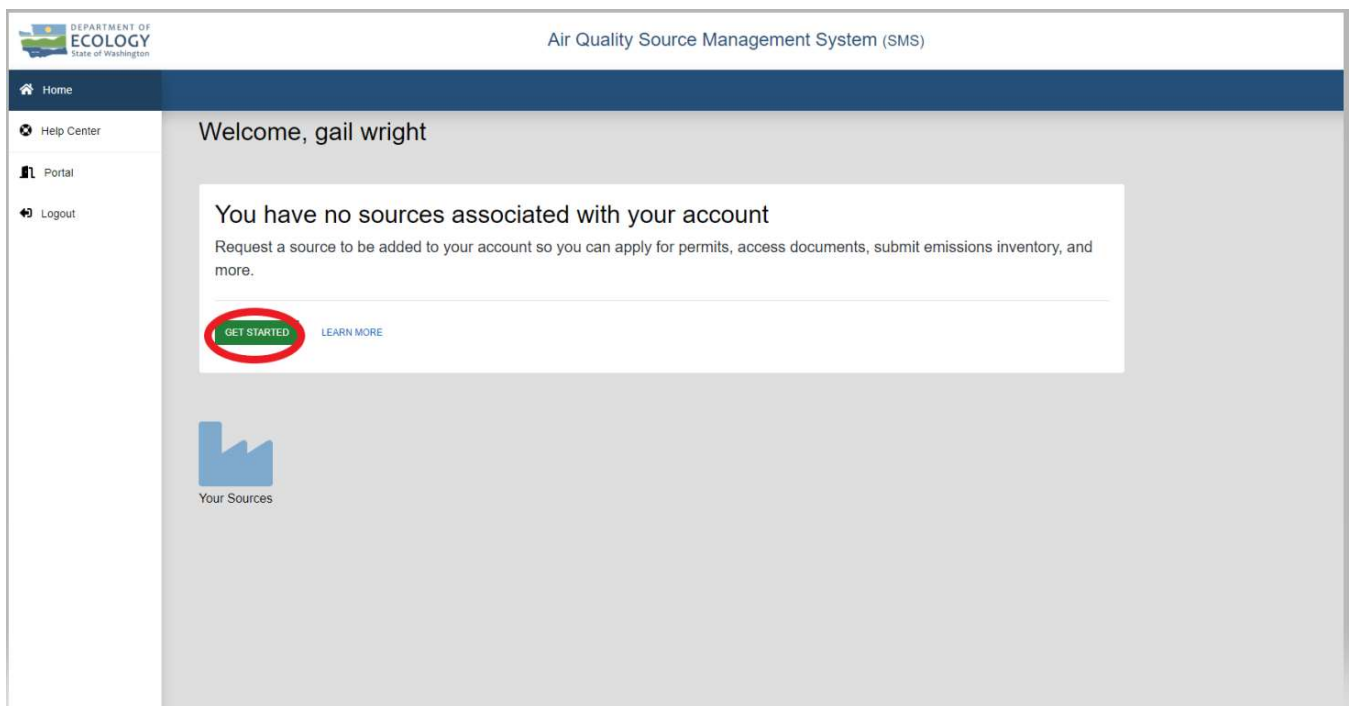
1.3. Click on “Continue” button.



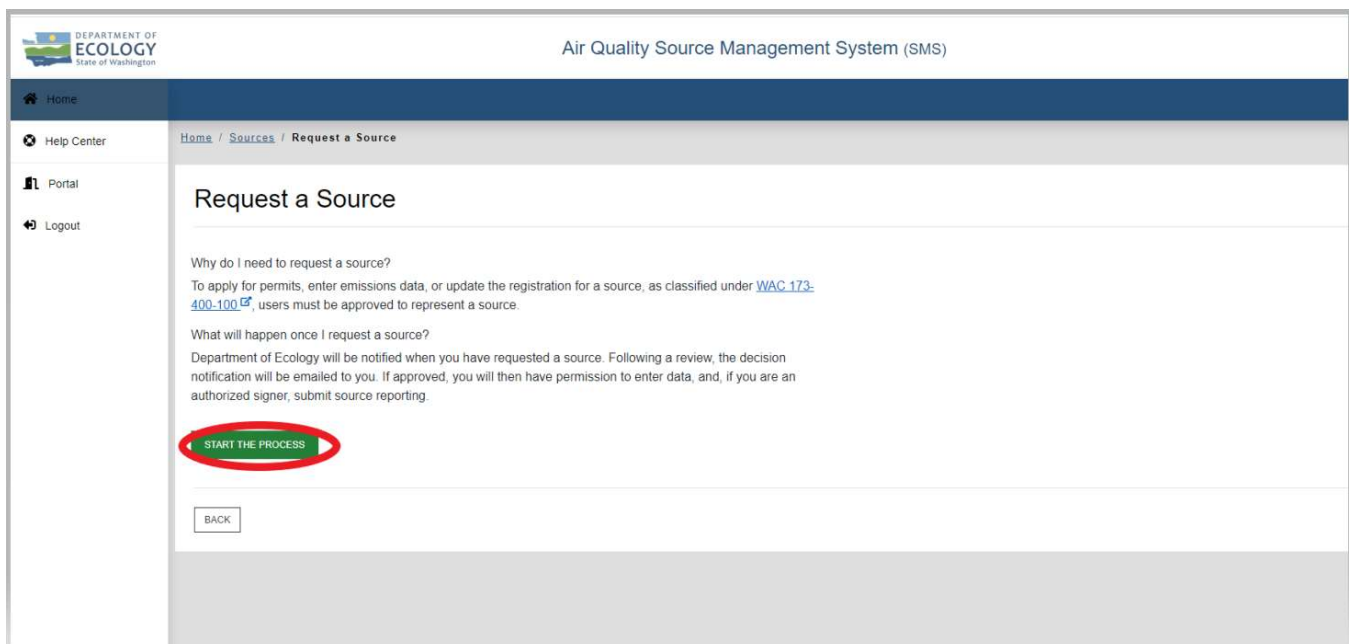
1.4. Click on “Go To SMS” button.

The owner or operator of the source is responsible for notifying the permitting authority of the existence of the source, and for the accuracy, completeness, and timely submittal of registration reporting information and any accompanying fee.

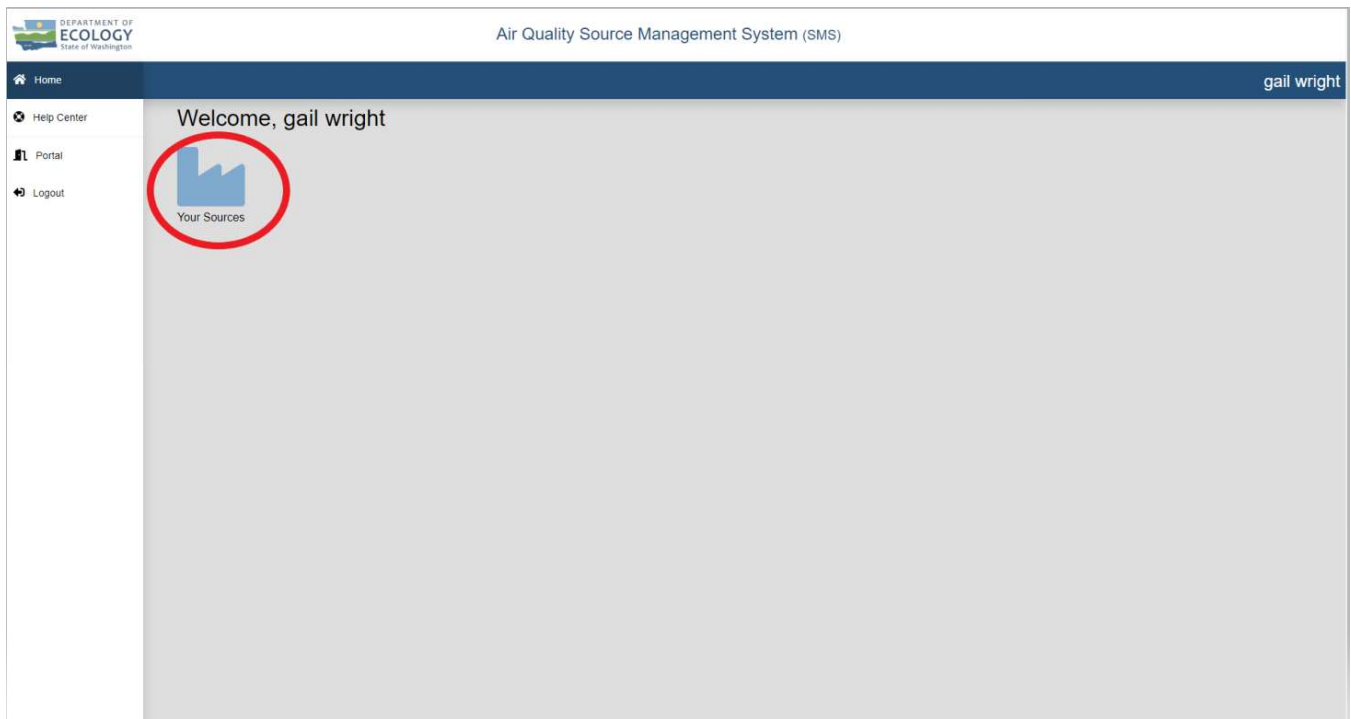
