For 2016 outreach efforts continued in a similar manner as 2014 - 2015 to ensure that information about where, how, and why to recycle CEP's was available to all state residents - especially smaller counties identified as having lower collection per capita than the state wide average. Specifically:

Billboards placed:

- •Shelton, WA Hwy 101 North of Air view way 12 weeks
- •Wenatchee, WA N. Miller St and N Wenatchee Ave. S 12 weeks
- •Wenatchee, WA various rotating metro locations- 16 weeks
- •Quincy, WA Hwy 281 and Hwy 28N 12 weeks
- •Yakima, WA 6 locations various metro 6 each at 16 weeks each
- •Tri Cities, WA 6 locations various metro 5 each at 5 weeks each
- •Shelton, WA Hwy 101 North of Air view way 4 weeks

In 2016 the WMMFA also contracted for Mobile ads generated via proximity to the billboard campaign ads The mobile campaign in the Tri Cities area generated a click thru rate of .55% Secondary Action rate of 12.22% by utilization of the billboards and landing page as illustrated below (over a one month period). The mobile campaigns in the Quincy, Yakima, Shelton, and Quincy areas had a similar click thru rate and secondary action rate of 5.52%

Other outreach utilized in 2016 (as in previous years) include a 50% or more co-operative advertising expenditure sharing with some of our collectors. Pend Oreille County Public Works (Newport, WA and E-Cycle Northwest - Sequim, WA) have been among participants in 2016. The outreach efforts as described here and as undertaken in 2016 are a cumulative ongoing effort. Posters, brochures, and co-op venues are a mainstay used throughout every year.

2017:

The WMMFA, based, in part, on input from Ecology purchased 36 weeks of billboard advertising in Longview, WA at the major intersection of Oregon Way and Industrial Avenue. Full size billboards were also placed in Centralia for 24 weeks at two locations. 12 weeks at W. Main and Cedar Street and 24 weeks at NE Kresky and NE Hampe Way.

The WMMFA also purchased 120 each 30 second radio spots on KIRO FM for broadcast within the Seattle listening area during prime driving times for the months of March and April of 2017. These radio spots were designed to emphasize the free recycling services provided by E-Cycle Washington as provided by the manufacturers through the WMMFA and to direct listeners to the E-Cycle WA web site to find a drop off site closest to them.

Throughout 2017 a major re-branding campaign was also undertaken by re-issuing new laminated poster sets and brochures (outdoor or indoor use) to over 60 collection site operators for use.

2018:

26 consecutive weeks of a print ad in The Giant Nickel (Tri-Cities WA area). The GIANT Nickel is published weekly as a regional classified want-ad buy/sell flyer. Circulation of the flyer is via multiple retail establishments and is available free of charge to consumers and households. Circulation area includes: Basin City, Benton City, Burbank, Connell, Ellensburg, Eltopia, Finley, Grandview, Granger, Kennewick, Mesa, Moses Lake, Othello, Pasco, Prosser, Richland, Sunnyside, Toppenish, Tri Cities, Union Gap, Walla Walla, Wapato, Warden, West Richland, Yakima, and Zillah. This particular outreach was dedicated to one processor, Clayton Ward Kennewick, in order to evaluate the impact of this type of outreach to a particular target collector. The results of the outreach are inconclusive at the time of this report submission.

The Authority reprinted 5000 English and Spanish brochures (example previously illustrated in prior editions of this section) and 600 laminated posters intended to be posted inside or out of all collector facilities. This inventory is meant to fulfill requests from collectors and other covered or non-covered entities that wish to inform the public of electronic product recycling opportunities. Replacement posters that degrade over time are replaced upon demand. Brochures are distributed to collectors and other locations upon request and automatically to collectors requesting posters.

The WMMFA contracted with Viamedia, Inc. to run a total of 600 each 15 second television ads created with the help of ecology based on our original video production produced in 2010 and referenced earlier in this section. These ads promoted E-Cycle Washington and were run during the Winter Olympics February 8th through February 25th on networks: USA, NBCS, MSNBC & CNBC. 720 15 minute ads were also run in February on channels HGTV, FOOD, CNN, A&E, Bravo, AMC, FS1, Freeform, SYFY, Hallmark, TRU, LMN,OWN, HLN,NFL and the NBA All Star Game.

In March of 2018 the WMMFA sponsored 190 each 15 second ads during the College Basketball March Madness season (March 13-April 2). Another 720 of these ads were run in March on the same networks as referenced in the February run. In a cooperative effort with the Department of Ecology the Authority sponsored the printing and insertion of E-Cycle Washington promotional material as shown below to approximately 150,000 households in Douglas and Spokane Counties.

2019:

After distributing approximately 6000 E-Cycle brochures throughout 2018 the Authority reprinted another 6000 brochures (5000 English and 1000 Spanish) for distribution in 2019 (sample brochure previously illustrated in prior editions of this section). The entire quantity of brochures printed for 2019 (6000) were distributed. In addition approximately 350 laminated posters used for the branding of E-Cycle locations were distributed to collection sites around the state. Inventory of brochures and laminated posters is maintained to fulfill requests from collectors and other covered or non-covered entities that wish to inform the public of electronic product recycling opportunities. Replacement posters used outdoors that degrade over time are replaced upon demand. Brochures are distributed to collectors and other locations upon request and automatically to collectors requesting posters.

In 2018, as described previously, the WMMFA contracted with Viamedia, Inc. to run a total of 600 each 15 second television ads created with the help of Ecology. For 2019 the Authority focused on billboards in more remote and less populated counties and communities. Specifically, roadside poster and full size bulletin boards were placed along highways surrounding Ephrata, Sequim, and Port Angeles, WA September through early December 2019. Another billboard campaign September through October included billboards and rotational posters in/near Bellingham, Burlington, Mt. Vernon, Wenatchee, Yakima, and Kitsap County, WA. Using a more aggressive and "targeted" approach for Spokane, WA the authority blitzed the Spokane metro area with billboards on major thoroughfares around Spokane including Market Street, Crestline, Bridgeport, Trent, Sprague, Freya, Progress, lvory, Lily, Euclid, and Maple avenues for the months of May through July 2019.

In a cooperative effort with the Department of Ecology the Authority sponsored the printing and insertion of E-Cycle Washington promotional material (a utility bill insert) as shown below to approximately 50,000 households in total within the communities of Anacortes, Asotin County, Mount Vernon, Pasco, and Pullman

The Authority also placed quarter and half page newspaper ads in the Kittitas County Rodeo program (single event ad), Omak Stampeded newspaper, and, the Peninsula Daily News (covering Clallam and Jefferson county) for the months of May through August 2019

Materials of Concern Export information

The preferred environmental standards that all processors contracted with the WMMFA must subscribe to require that any materials of concern (materials that present potential risk to humans or the environment) exported to a NON-OECD (Organization for Economic Co-operation and Development) member country have approval from the destination country and confirmation from the US Environmental Protection Agency.

Total weight of all <u>materials of concern</u>, including unwanted electronic products, electronic components, and electronics scrap collected by the WMMFA that have been exported from Washington state for plan year 2019, from processors used by the WMMFA, to countries that are not members of the Organization for Economic Co-operation and Development or the European Union = 0. This information is provided to the WMMFA by each processor. Destination countries for "materials of concern", and non- materials of concern, where provided by processor, (commodities) can be found in section 5.c.d. of this report

NOTE: The WMMFA annual report submitted in 2015 indicated that zero pounds of materials of concern (MOC) were exported to NON-OECD countries. In early 2016 we learned that one of our processors, Total Reclaim, had been exporting flat screen devices to Hong Kong, which is not a member of the OECD. The amount of devices shipped to Hong Kong was estimated at approximately 1.5 million pounds for 2015, or, 3.5% of all pounds collected in 2015. It was also determined that a quantity equating to approximately 1.9% of all devices collected since start up were exported to Hong Kong by this processor.




Documentation of work done with direct processors used by the Standard Plan to promote and encourage the design for recycling of new products (CEP's) destined for end of life recycling under this program


Two years ago we reported that 85% (by weight) of the electronic products collected by the WMMFA (specifically CRT TV's and CRT Monitors) were no longer being manufactured for sale in the US. Public recycling needs for our CEP's are moving rapidly away from CRT to newer flat screen technologies. In fact, for the 1st time going on 11 years of E-Cycle collections, unit volume of flat screen technology devices collected exceeds that of CRT devices. Some reports indicate the average life of a CRT TV is approximately 11 years while the average life of an LCD/LED TV is 16-20 years. The charts provided below illustrate the fact that WMMFA collected product "mix" is more closely aligned with products manufactured since program inception. It is encouraging that newer covered devices, TV and monitor in particular, weigh 1/3 to 1/2 less than comparably sized obsolete CRT models. While member manufacturers have been successful in reducing the weights and longevity of covered electronic products significantly many challenges remain in the recycling of these newer products, especially flat screen technologies such as LCD, and LED monitors and televisions. For this reason the WMMFA has implemented a collaborative approach between registered processors and our member manufacturers and continually shares the information with manufacturers. Specifically, the March Board meeting of each year is used for re-cap discussion of DfR.

The Authority previously reported intent to conduct annual surveys of all registered processors on an annual basis. The last formal DfR (design for recycling)survey was in September 2018, a summary of which is provided below. After phone discussions with two of the WMMFA's processors by the Executive Director it seemed apparent that the 2019 survey results would not represent a significant change from 2018. In order to facilitate more direct and timely communications on this topic a face to face meeting with processors and manufacturers is scheduled for October 1, 2020. This meeting will be held as in conjunction with the WMMFA's annual "in person" board meeting scheduled for the same date. The purpose of the meeting will be to allow for two way communications between manufacturers and processors to identify obstacles, concerns, constraints, and risks associated with the dismantling, recycling, and ultimate disposition of products most prevalent within the collection stream. This change is seen as a significant improvement over the previous DfR efforts by the Authority.

The results of the 2018 survey summary shown below were provided to and discussed with the WMMFA board at the March 2019 regularly scheduled board meeting.

If one kind of screw is used on each product it would save much labor cost. Example: Phillip's #2 for PC's, Torx for TV's, and Hex for Monitors. The plastic used for cases of flat screens of lesser value and difficult to find positive downstream recycling value if any.
 - 3. Properly identify plastic type. Example: most older units have their plastic type recycle sign on them, but newer electronics rarely have their recycle type. Residuals after dismantle of flat screens have little or no value (mostly labor expense)
- 2. Which Top 3 "materials of concern" currently used within CEP's, if revised or eliminated would have the most positive impact on your direct or downstream costs?

Tablets, E-Readers & Portable DVD Players are small and lightweight. There is little opportunity to re-coop the labor to dismantle with rates comparable to other per pound items.

- Standardizing the screws used on all electronics, if not, as many as possible.

Based on feedback from our network of collectors typically involved in refurbishment and/or resale of used electronics the ratio of reused to recycled products varies considerably by type of collector, and, type of product. An important factor for reuse in 2019 was screen size for used working flat screen products. The larger screen TV's (greater than 30") sell well. Many of our non-profit collectors, and independent retailers, perform some refurbishing and reuse operations on higher value (larger screen) devices as an alternative to submitting them to this program for recycling. However, since the E-Cycle Washington program was designed primarily as an end of life program for unwanted electronics many of our collectors focus on getting CEP's to the program for responsible recycling of contents due to the low sales value of refurbished equipment in relation to the sales price of new equipment available at main stream or on-line retailers. For 2019 we estimate that a weight equivalent to approximately 108,000 pounds of COMPUTERS (5052 units of laptops and towers combined) were put into reuse by our collectors. This estimate is based upon an approximate 5.4% re-use estimate across all of our collectors on the 9.4% (by weight) of all desktop or laptop product collected. We estimate a negligible amount (nil%) of CRT TELEVISIONS were put to reuse. Of FLAT PANEL TELEVISIONS (plasma, LCD, and LED) we estimate that approximately 3.6% by weight (165,120 pounds / 6880 units) went to reuse. FLAT PANEL MONITORS of 36,200 pounds, or 3,300 units were sent to reuse by collectors. CRT MONITOR reuse was negligible (0%). These pounds are NOT included in our collected pounds reports as they are sent to reuse directly by the collectors and therefore not transported or processed within the E-cycle program. None of the WMMFA's direct processors engaged in re-use or refurbishment of end of life products for pounds collected in 2019. Therefore, 100% of reuse and/or refurbishment for resale/reuse was done at the collector level.

NOTE: The Authority has no formal data collection means to obtain re-use volumes from our collectors. In fact, many of them compete for collections from the donating public. For this reason we report with reasonable accuracy, the re-use pounds by product type from our PROCESSING network and we make broad estimates about re-use data at the COLLECTOR level based on the types of products they collect and informal conversations with collectors as to the volume of products being sent to re-use. The Preferred Processing Standard requires processors for the WMMFA have adequate closure plans and a sufficient financial instrument that assures against abandonment of any CEP's, components, parts, materials or residuals. This section contains a summary of the Financial Closure Plan of each of the WMMFA's contracted processors.
