


The combined litter efforts of the Community Litter Cleanup Program, Ecology Youth Corps, Department of Natural Resources and the Department of Corrections:

# Notes About the Information Contained in This Presentation


- **Population** data from OFM 2016 Population Estimates

- Hours represents crews supervisor and crew hours.
- Pounds represents both litter and illegally dumped materials picked up (if reported in bags or cubic yards, the figures were converted to pounds using a standard formula)
- Miles represents the number of shoulder miles cleaned
- Acres represents the number of acres cleaned
- Illegal Dumps represents the number of illegal dump sites cleaned up
